- e) Bid documents should be addressed to the Head, Procurement and Disposal Unit- Kakumiro, P.O Box 522, Kakumiro and delivered to the same office on or **before 7th October, 2022 at 10:00 am** local time.
On the same day, all bids/applications will be opened in the Boardroom at new administration block Head quarters, starting at **10:30 am** in the presence of bidders or their representatives who may choose to attend.
- f) Late bids/applications shall be rejected.
- g) All bids must be accompanied with bid securities in form of a bank guarantee.
- h) A bidder shall apply for only one item.
